APPLICATION PROCEDURES

1. Complete the *Application for Outdoor Activities*. Be sure to indicate your first and second choices for date and sites requested. Training cards or other proof of training for camp trained person, First Aider and lifeguard are required at the time of application.
2. Only those applications, mailed or hand delivered, with total fee enclosed will be processed. Full payment is required for your first choice. If fees per site are different, adjustments in payment will be made.
3. A confirmation packet will be sent to you prior to your camping date. If we are unable to accommodate your requests, your total fee will be refunded.
4. If you must cancel, contact the Kalamazoo Service Center at least two (2) weeks in advance. Last minute cancellations will not receive a refund unless an emergency is proven, at the discretion of the council.
